This mine is not listed as a new mine in 1919, and it may have been in operation prior to that time. Although the mine served a local trade almost exclusively, it did ship coal in 1933. No production figures were noted for the years 1936 and 1917. It is noted in both these years that the mine had a new operator; however, the new operator is not identified. The mine is listed as not operating in 1944, and since no further reports were noted for this mine, it is assumed that the mine ceased operations at about that time. However, it is possible that the mine continued to be operated but was not reported or that the mine was operated and reported under some other name following 1944.
