This mine is not listed as a new mine in 1909, and it may have been in operation prior to that time. The mine reported continuously from 1909 through 1917. Although the mine is not listed closed in 1918/1919, no listings were noted for the mine following 1917. Either the mine ceased operation in about 1918, or it ceased reporting at about that time. In the 1912 SEBR, it is noted that this mine "has a contract for supplying a couple of mills with coal the year around."
