Basic Data (excerpted from primary sources):

This mine is not listed as a new mine in 1916, and it may have been in operation prior to that time. The mine is not listed as closed following 1917; however, no listings were noted following 1917 until 1928, and in 1928, the Rumph Mine is listed as a new mine. It is not known if the Rumph Coal Mine listed from 1928 through 1934 was at the same location as the Rumph Coal Mine listed in 1916 and 1917. This mine is not listed as closed or not operating in 1934, but no listings were noted for the mine following 1934. It is not known if the mine ceased operations or if it ceased reporting following 1934.

Notes:

Although specific information about the owner of this mine was noted only in 1916 and 1917, since the name of the superintendent of the mine from 1928 through 1934 is the same as the name of the owner of the mine in 1916 and 1917, it is likely that C.W. Rumph maintained ownership of the mine throughout the years the mine was operated.

No information was noted that definitely indicates that the Rumph Coal Mine reported from 1928 through 1934 and the Rumph Coal Mine reported in 1916 and 1917 (which is located at Planning Unit 030, AML location 120) were the same mine at the same location.
