(excerpted from primary sources):

This mine is listed as "only recently. . .opened" in 1910; however, McLean County Historical Society (1978) indicates that "Abraham [Youngquist] opened a coal mine on his homestead [in Section 10] the first winter [1883 or 1884]. Coal was dug with a pick and shovel, for own use and to supplement their income." It is not known if the area of Section 10 mined by Abraham Youngquist is the area of Section 10 (NE) identified by this Planning Unit and AML location. The Youngquist mine reported production from 1909 through 1915; no reports were noted for the mine from 1916 through 1924; and the mine again is reported from 1925 through 1934. It is not known if the mine was in operation from 1916 through 1924; however, a WCB map of the Youngquist Mine from the year 1924 was noted. The 1925 report for the Youngquist Mine does not indicate that the mine is a new mine in that year, and it is possible that the mine did continue operations from 1916 through 1924, but did not report. The mine is not listed as closed or not operating in 1934, and it may have continued operations but not reported (see Notes, below). McLean County Historical Society does indicate that "Coal mines operated on that land [Section 10] until 1941, when it [sic] was closed permanently."

Notes:

Differing areas of Section 10 apparently were mined under the name Youngquist Coal Mine, as evidenced in the 1910, 1912, 1914, and 1916 SEBRs. Legal locations noted in each of these sources are listed below.

1910: T144N, R83W, Section 10, NE, SE
1912: T144N, R83W, Section 10, SE
1914: T144N, R83W, Section 10, NE, SW
1916: T144N, R83W, Section 10, SE

It should be noted that the legal location listed for 1912 and 1916 is not the legal location identified by this Planning Unit and AML location (Section 10, NE). Additionally, although a WCB map does exist for this mine, it does not provide a part section, but lists the legal location for this mine only as T144N, R83W, Section 10.

No information was noted, with the exception of the 1924 WCB map (which includes no part section), that the Youngquist Coal Mine reported from 1925 through 1934 was located at the same location(s) as the Youngquist Coal mine reported from 1909 through 1915.

The Brown Coal Mine also may be located at this Planning Unit and AML location. It is interesting to note that the last year listed for the Youngquist Mine is 1934, and the first year listed for the Brown Mine is 1935. The Youngquist Mine is not listed as closed or not operating in 1934, and the Brown Mine is not listed as a new mine in 1935. Additionally, information noted in McLean County Historical Society (1978) indicates that "Coal mines were operated on that land [Section 10] until 1941, when it [sic] was closed permanently." It may be that the Youngquist Coal Mine and the Brown Coal Mine were the same mine; however, no information specifically addressing this possibility was noted.
