The 1916 SEBR indicates that this mine was "recently opened" when the mine was inspected on 5 February 1916. Listings were noted for this mine in 1915, 1916, and 1917. The mine is not listed as closed or not operating following 1917; however, no further listings were noted for the mine. It is not known if the mine ceased operations or was operated but not reported following 1917 (see Notes, below).

The Hazen Coal Mine also is located at this Planning Unit and AML location. It should be noted that Leonard et al. (1925) indicate that the Hazen Coal Mine was located at T144N, R86W, Section 8, NW corner; the Reichenberg mine was located at T144N, R86W, Section 8, NW, NW, NW. The last listing noted for the Reichenberg mine was from 1917; the first listing noted for the Hazen mine was from 1919. Although no information was noted that definitely relates the two mines, it is possible that the Reichenberg mine became the Hazen mine or that both mines were operated at about the same location.

A mine operated by C.J. Dolan in about 1884 also may have been located at this Planning Unit and AML location.
