Basic Data (excerpted from primary sources):

A listing was noted for a Max Just Coal Mine in 1921; this listing does not indicate that the mine was a new mine in that year, and it is the only listing noted under the name Max Just Coal Mine. No listings were noted for a Max Just mine or for a Just Coal Mine from 1921 until 1927, when the Just Coal Mine is listed as a new mine (see Notes, below). The Just Coal Mine was operated and reported continuously from 1927 through 1935; however, production figures are not provided for 1935, and the 1935 CMID indicates that the mine was "mining coal for own use." No listings were noted following 1935; it is not known if the mine continued to be operated for the operator's own use and therefore was not reported, or if the mine ceased to be operated following 1935.

Notes:

Harrington (1934a) indicates that this mine was located in T138N, R85W, Section 8; however, Harrington (1934a) does not provide a part section. Therefore, it is not known if this mine was located at this Planning Unit and AML location (T138N, R85W, Section 8, NE), or if it was situated in some other portion of Section 8. Additionally, it is not known if the Max Just Mine listed in the 1921 CMID was situated at the same location as the Just Coal Mine first listed in 1927. It should be noted, however, that Max Just was the superintendent of both the Max Just Coal Mine and the Just Coal Mine.
