Basic Data (excerpted from primary sources):

The Carbon mine is listed as a new mine in 1942, and it is reported continuously from 1943 through 1952 and from 1954 through 1967. In 1952, this mine was named the Carbon Coal Mine No. 1 and a Carbon Coal Mine No. 2 (same superintendents) is listed as a new strip mine. In 1953, only the Carbon Coal Mine No. 2 is listed. From 1954 to 1957 the only mine listed is the Carbon Coal Mine No. 1, and from 1958 through 1967--except for 1959 (when the mine again is listed as the Carbon Coal Mine No. 1)--no distinction is made as to which Carbon Coal Mine is being reported. It is not known if both mines were operated simultaneously and reported under one overall name following 1953 (the last listing for a Carbon Coal Mine No. 2), or if the Carbon Coal Mine No. 2 was closed sometime after 1953. The last listing noted for the mine (or mines) is in the 1967 CMID; it is not known if the mine was operated following 1967 and not reported, or if the mine was closed at about that time.

Notes:

Brant (1953) indicates that the Timpe & Nellis mine was located at T139N, R86W, Section 23; however, Brant (1953) does not provide a part section. Therefore, it is not known if the mine (or possibly mines) was located at this Planning Unit and AML location (T139N, R86W, Section 23, NW, S1/2), or if the mine(s) was situated in some other portion of Section 23. Additionally, of the two mines discussed above, only the Carbon Coal Mine No. 2 (superintended by Timpe & Nellis--aka Nillis) was in operation in 1953. However, Brant (1953) likely reports information compiled for some number of years prior to 1953. In any event, it is not clear which of the above mines is that referred to by Brant (1953) as located in Section 23, and it is not definitely known that both mines were situated in Section 23.
