Basic Data (excerpted from primary sources):

This mine is listed as a new mine in 1933, and it was operated and reported in 1934. No listing was noted in 1935, and the mine again is listed as a new mine in 1936. It should be noted that the 1933, 1934, and 1936 Hendrickson Coal Mine listings are included under Bowman County rather than Slope County. The mine was operated and reported in 1937 and 1938; no listings were noted following 1938. It is not known if the mine ceased operations, if it was operated but not reported, or if it was operated and reported under some other name following 1938.

Notes:

Harrington (1934) indicates that this mine was located at T133N, R99W, Section 17; however, Harrington (1934) does not provide a part section. Therefore, it is not known if this mine was located at this Planning Unit and AML location (T133N, R99W, Section 17, SE, NW), or if it was situated in some other portion of Section 17.

It is not known definitely that the Hendrickson mine reported from 1936 through 1938 was operated at the same location as the Hendrickson mine operated in 1933 and 1934 (which is the nine most closely associated with the legal location noted in Harrington 1934).

It should be noted that Harrington (1934) lists this mine with Bowman County mines.
