This mine is not listed as a new mine in 1919, and it may have been in operation prior to that time. The 1920 CMID indicates that a new fan had been installed in the mine, and a number of brick "stoppings" had been made. Leonard et al. (1925) indicate "This is a drift mine, which is lighted by electricity and the pump is driven by electric power." The mine was operated and reported continuously from 1921 through 1925, when the mine is listed "Closed." No further listings were noted for this mine, and it appears likely that the mine was not operated following 1925.

Notes:

The 1924 WCB map that illustrates this mine does not provide a part section in its legend; however, the map does indicate that the mine was located at T155N, R84W, Section 3, SW, SE. Leonard et al. (1925) indicate that this mine was located at T156N, R84W, Section 33, SE. No information was noted to clarify this discrepancy. The mine may have extended into both sections (the extreme southeast corner of Section 33 and the extreme northwest corner of Section 3 are contiguous); however, it would appear that if this was the case, the mine would have been situated in the northwest portion of Section 3. Since both locations noted for this mine are included in areas identified by planning units/AML locations, this mine has been included with Planning Unit 100, AML location 296 (T155N, R84W,

Section 3, SW, SE) and Planning Unit 100, AML location 294 (T156N, R84W, Section 33, SE, SW).

The Duhamel/Roosevelt/Burlington Mutual Aid Mining Corp. mine also is located at Planning Unit 100, AML location 296, and the Houston/Cherry Vale Coal mine also may be located at Planning Unit 100, AML location 296.

No other mines were noted in association with the legal location identified by Planning Unit 100, AML location 294.
