Basic Data (excerpted from primary sources):

The first reference noted for this mine is dated 1898 (CAL 1898), and the mine may have been in operation prior to that time. According to the 1910 SEBR, "The mine is thoroughly equpped with all modern coal mining appliances. An electric seven ton motor is used for hauling out the trips. Undercutting of the clay is done with pneumelectric coal punchers, and the trips are pulled onto the tipple by an electric hoist. An automatic register registers the weight of each car as it crosses the platform." Coal was dumped directly on a shaker screen that had 90 sq. ft. of surface. "The screenings collect in a small mine car which, when loaded, is drawn up the slope by the electric hoist and dumped into chutes that supply the power plant boilers. A power plant is run in connection with the mine that supplies light and power to Kenmare." The 1912 SEBR indicates that this mine had been in operation for a number of years, and it had become necessary "during 1911 to open a new slope." By 1914 (SEBR 1914), the National Briquetting Company (of Minneapolis) was incorporated under the laws of South Dakota. Additionally, "The mine [was] entered by a slope (main entry of 1,200 ft. by early 1914) and a long trestle connect[ed] it with the tipple. . .a well timbered drift has recently been driven and part of the long trestle will be abandoned. An electric fan is used to

accelerate the ventilation. The entries are lighted with electricity." By early 1916, the main entry of the mine extended 1,800 ft. According to the 1916 SEBR, "The power plant which supplies the city of Kenmare with electricity, is situated beside the mine and was formerly owned by the Northern Briquetting Company but has lately been sold to a different concern." Also according to this report, "The mine is connected to the Soo by a spur on which the Mining Company operate their own engine to haul the coal to the Soo right of way." The 1918 SEBR indicates that the concern that purchased the power plant located at this mine was the General Electric Company. This report also indicates that the National coal mine was "formerly the Smith (Dry) Coal Mine." Although no listings were noted for the National Coal Mine following those in the 1918 SEBR, listings were noted in the 1919 and 1920 CMID reports for a Peoples Power, Fuel, & Clay Products Co. The superintendent of this mine in 1919, J.W. Deemy, was the president and secretary of the National Briquetting Company (owner of the mine). Therefore, although no definite information was noted, it has been assumed that the National Coal Mine was operated and reported as the Peoples Power, Fuel, & Clay Products Co. in 1919 and 1920. The 1920 CMID indicates that this mine was closed for repairs. No further listings were noted for the mine; it is not known if the mine ceased to be operated, if it was operated but not reported, or if it was operated and reported under some other name following 1920.

Notes:

The 1910 and 1912 SEBRs indicate that this mine was located at T160N, R88W, Section 7, Lot 1 (i.e., NE,NE), which is not identified by any Planning Unit/AML location. The 1914, 1916, and 1918 SEBRs indicate that this mine was located at T160N, R88W, Sections 18, 7, and 6; however, they provide no part section. Therefore, it is not known if this mine was located at Planning Unit 098, AML location 521 (T160N, R88W, Section 6, NE) or if it was situated in some other portion of Section 6. Additionally, although the 1910 and 1912 SEBRs indicate that the mine was not situated in that portion of Section 7 identified by Planning Unit 098, AML location 520 (T160N, R88W, Section 7, NW), it is possible that the mine extended into this area sometime between 1913 and 1920. Therefore, both Planning Unit/AML locations have been included with this mine.

The Krenelka Coal Mine also is located at Planning Unit 098, AML location 521, and the Big Four Coal Mine also may be located at Planning Unit 098, AML location 520.
