Basic Data (excerpted from primary sources):

This Cedar Coulee Mine is listed as a new mine in 1928; this mine was operated and reported from 1928 through 1932. The mine is included in the 1933 and 1934 CMIDs; however, production figures are not provided. The 1934 CMID lists a Stewart Coal Mine as a new mine; although no definite information was noted to relate this mine with the Cedar Coulee Mine reported from 1928 through 1932, C.E. Stewart was the superintendent of that Cedar Coulee Mine and he was superintendent of the Stewart Coal Mine listed in 1934. Harrington (1934a) lists a Cedar Coulee Coal Mine at T154N, R97W, Section 20, but this source does not list a Stewart Coal Mine. Therefore, it has been assumed that the Stewart Mine (No. 1) reported new in 1934 and not operating in 1935 and the Stewart Mine (No. 2) reported from 1935 through 1938 likely were at the approximate location of the Cedar Coulee Mine reported from 1928 through 1934. The Stewart Coal Mine (apparently No. 2) is listed as not operating in 1937 and 1938. A Cedar Coulee Mine No. 2 associated with John Kulzcyk is first listed in 1939; this Cedar Coulee Mine No. 2 was related to this Planning Unit and AML location from WCB maps (dated 1940, 1945, and 1961a,b), which list "John Kulzcyk [or Stephen Kulzcyk] Cedar Coulee Mine No. 2." This mine is listed closed in 1941 and 1942; however,

production figures are provided in both years, and listings were noted for the mine through 1967. No listings were noted for this mine following 1967; although it is likely that the mine ceased to be operated at about this time, it is possible that the mine was operated and not reported or that it was operated and reported under some other name following 1967. Although no information was noted relating the Cedar Coulee Mine (1928 through 1934), the Stewart Coal Mine(s) (1934 through 1938), and the Cedar Coulee Mine No. 2 (1939 through 1967), the name Cedar Coulee Mine, the superintendent (Stewart), locations noted in Harrington (1934a) and on WCB maps (1940, 1945, and 1961a,b), and the continuity of years of operation lead to the assumption that these mine names likely refer to the same mine.

Planning Unit 076, AML location 464 and Planning Unit 076, AML location 469 define one location--T154N, R97W, Section 20, NE).

All locations noted for this mine place it in portions of T154N, R97W, Section 20 (a portion of which is identified by Planning Unit 076, AML location 464 and Planning Unit 076, AML location 469), with the exception of one WCB map (1961b), which could place it in a portion of Planning Unit 076, AML location 465 (T154N, R97W, Section 17, SW). This location is somewhat questionable because the map lists the Rosenquist Lease (see Alfred Hilde's Cedar Coulee Mine discussion with Planning Unit 076 and AML location 465) in Section 17, SW. However, since there is some possibility that the mine described on these pages could have extended into Section 17, SW, it has been included with Planning Unit 076 and AML location 465.

A separate Cedar Coulee Mine (Hilde's Cedar Coulee Mine--later Rosenquist Coal Mine) also is located at Planning Unit 076, AML location 465.

The Van Allen Coal Mine also is located at Planning Unit 076, AML location 464 and Planning Unit 076, AMY, location 469.
