Notes:

Harrington (1934a) and the 1937, 1939, 1940, 1941a, 1942, 1944 and 1945 WCB maps indicate that this mine was located in T146N, R82W, Section 13; however, these sources provide no part section. The 1941b WCB map indicates that this mine was located in T146N, R82W, Section 24, NW, which location is not identified by any Planning Unit or AML location. Section 24 is directly south of Section 13, and only one Figenskau Coal Mine No. 2 is reported in CMID reports;

therefore, it has been assumed that Figenskau Coal Mine No. 2 extended from Section 13 into Section 24. This being the case, it is possible that at least parts of Figenskau Coal Mine No. 2 were situated within T146N, R82W, Section 13, SE (this Planning Unit and AML location); however, since no part section was noted in relation with this mine's situation in Section 13, it is not known if the mine was located at this Planning Unit and AML location or if it was situated in some other portion of Section 13.
